## 1. Required Documents

Before the trailer can be released, the Renter must provide the following:

- **Valid Driver's License**
- **Second form of ID (Passport)**
- **Proof of Vehicle Insurance** covering the towing vehicle
- **Payment Details** (Credit Card or Debit Card)
- **Vehicle Details** for the towing vehicle (Make, Model, Year, Plate #)
- **Security Deposit**
- **Signed Rental Agreement**

Failure to provide any document may result in cancellation of the rental.

### **3. Rental Pricing**

Renter agrees to pay the following rates:

- **Per Week (7 days):** \$689
- **4 Weeks (28 days):** \$1,899

Any additional time beyond the selected rental period will be charged according to the applicable rate.

### **4. Security Deposit**

A **refundable security deposit** of \$500 is required.

The Owner may deduct charges for:

- Damage
- Missing items
- Late return fees
- Improper use

The remaining balance will be refunded within 1 day of return.

### **5. Rental Term**

## 7. Use of Trailer

The Renter agrees to:

- Use the trailer safely and lawfully
- Tow only with a properly rated vehicle
- Ensure hitch, safety chains, lights, and brakes operate correctly
- Not exceed load limits or trailer capacity
- Not use the trailer for illegal purposes

No subleasing or transfer of this agreement is permitted.

## 8. Insurance & Liability

Renter confirms they have **valid insurance** for the towing vehicle.  
Renter is fully responsible for:

- Any damage to the trailer during rental
- Any accidents or injuries involving trailer use
- Any fines or citations issued during rental

Owner insurance does **not** cover the renter or towing vehicle.

## 9. Late Returns

Late returns are subject to:

## 10. Damage, Loss, or Breakdown

Renter must notify Owner immediately if:

- The trailer is damaged

- The trailer becomes unsafe or inoperable
